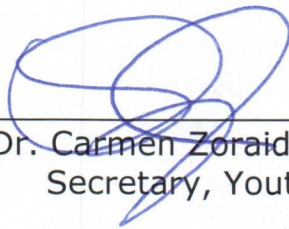
V. MOTION TO ADJOURN
