a. AMSI vs OEG: Notification of Judgment

Dr. Joaquín Santiago Santos presents the Notification of the Judgment received from the Court of First Instance, San Juan Superior Part, in which, upon attending to the motion for reconsideration, the reply and rejoinder, the Court decides that the requested reconsideration is not admitted.

a. Communication about Act No. 87 - to regulate recruitment and hiring of workers to work outside of Puerto Rico

Dr. Joaquín Santiago Santos presents a letter received from Atty. Jenny Mar Cañón Feliciano, Director of the Workforce Development Program, which informs about Act No. 87 of June 22, 1962. This act establishes the rules to formalize any work contract implying Puerto Rican workers that will work outside of Puerto Rico. They recommend that in order to assure compliance with this Act and all its provisions, they





must consult with the Placement Officer of the Employment Service of the Single Management Center, or with Mr. Carlos Román.

b. AP 2023-2024 Notification

Dr. Joaquín Santiago Santos presents a letter received from Mrs. Yolanda Rivera Ortiz, Special Assistant a/c Planification, Evaluation, Validation, and Statistics of the Workforce Development Program, in which they notify that after completing the evaluation, as stipulated in the Program Planning Guide for the years 2022-2023, the requested changes approval is granted.

c. Final determination of the single audit ALDL Caguas-Guayama AF 2022-2023
