- The Proposal Evaluation Committee held four ordinary meetings and a Referendum.
- ii. In the Referéndum held on October 28, 2022 nine proposals were considered that benefit participants from the towns of Caguas, Cayey, Guayama and Gurabo in the Work Experience, Transitional Jobs, and On-the-job training activities for a total amount of \$305,369.33. In addition, an amendmend that benefits Guayama's participants, for a total amount of \$833.63 was considered. Ten participants will benefit from job opportunities.
- iii. Twenty-nine proposals and amendments, seventeen new proposals, and twelve amendments were also evaluated in the ordinary meetings.
- iv. The seventeen proposals fully considered from the Private Sector are distributed in the following programatic activities:





- On-the-job training, Job Experience, and Transitional Jobs to serve 137 participants. Total investment for these proposals amounts to \$1,273,776.28.
- v. Twelve amendments were fully considered from the Private Sector under the Adults and Dislocated Workers Programs from the towns of Aguas Buenas, Aibonito, Caguas, Cayey, Guayama, Gurabo, and Trujillo Alto to serve 16 participants.
